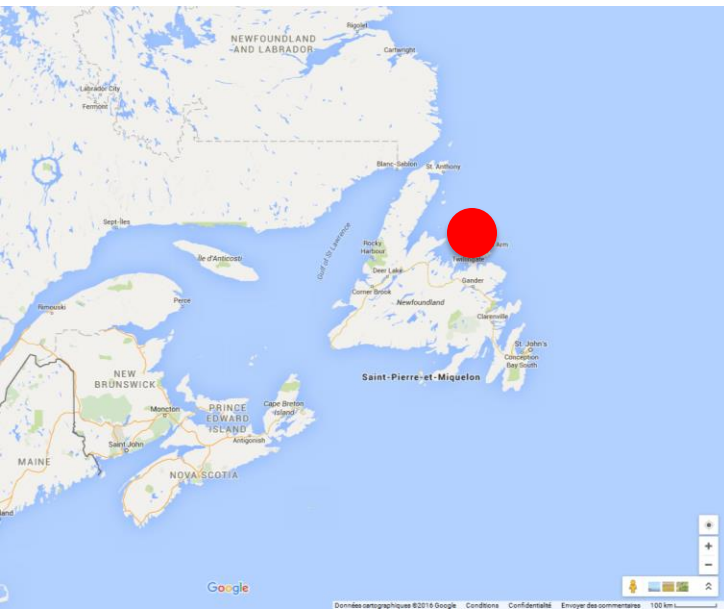

AUTONOMOUS GAS STATIONS IN SAGUENAY-LAC-SAINT-JEAN AND GASPÉSIE (QUEBEC)



- CED has helped a retail project consisting of autonomous gas stations. For small and remote communities, access to gasoline is precarious as profitability is not high enough to sustain a gas station. Thus, the solution is un-staffed gas station, where surveillance is made from a clerk in a remote gas station.



WIND POWER IN GASPÉSIE (QUEBEC)



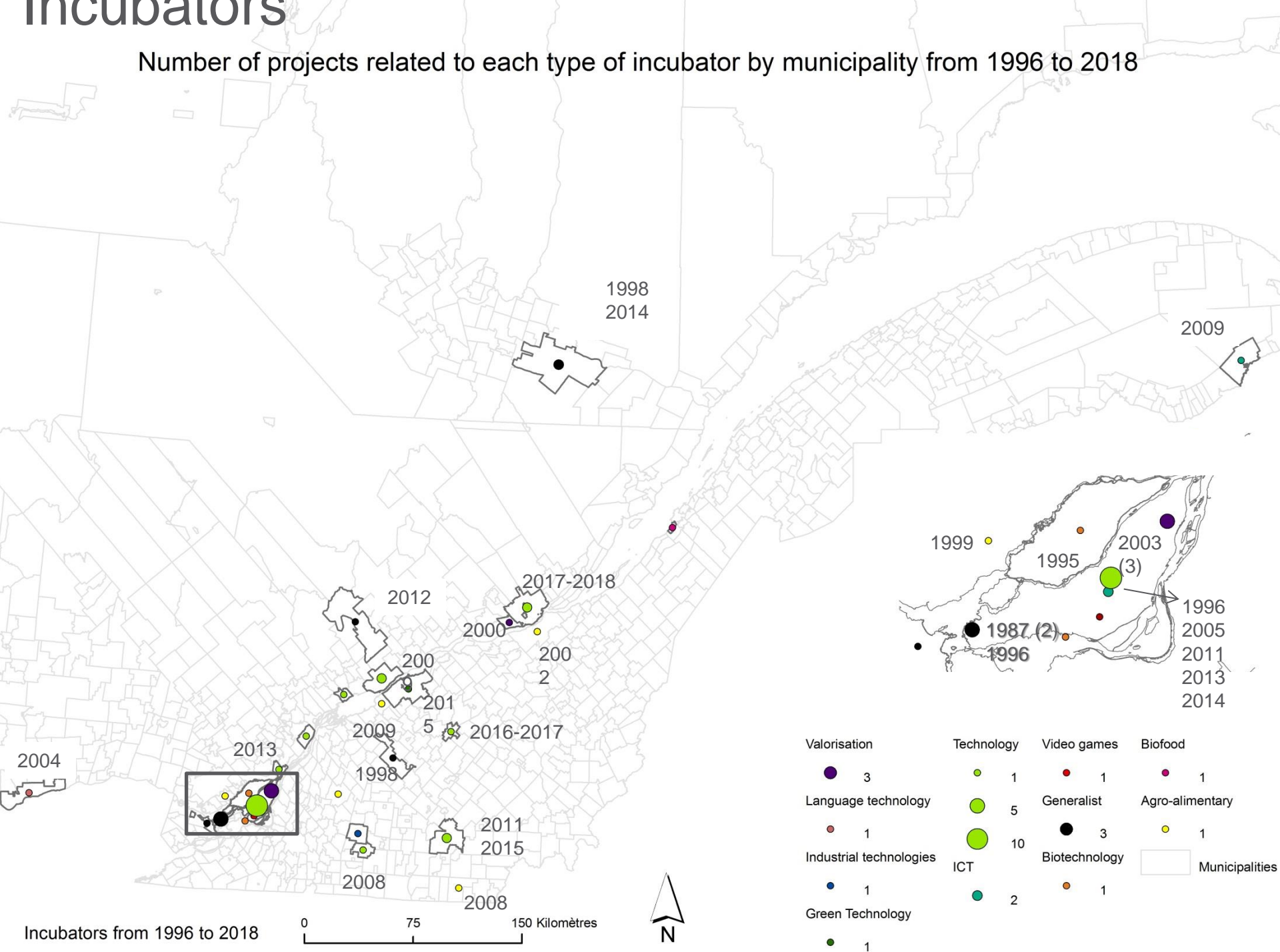
- The Gaspésie—Îles-de-la-Madeleine region and the adjacent Matane RCM, are a designated region for the wind power industry. It is the focal point of the development of the wind industry and thus public policies are conceived as to enable the creation of a local industry.
- The Government of Québec via its publicly-owned energy company, Hydro-Québec, launched the first bidding for the creation of a windfarm in the designated region in 2003. To make sure that the region reaps benefits from this energetic resource, it was determined that at least 40% to 60% of the global cost of the project must come from the region. Later, that criteria was relaxed as to have a minimum of 60% of the global cost realised in the province of Québec and 30% of the cost of the turbines must come from the designated region.

Number of projects related to each type of incubator by municipality from 1996 to 2018

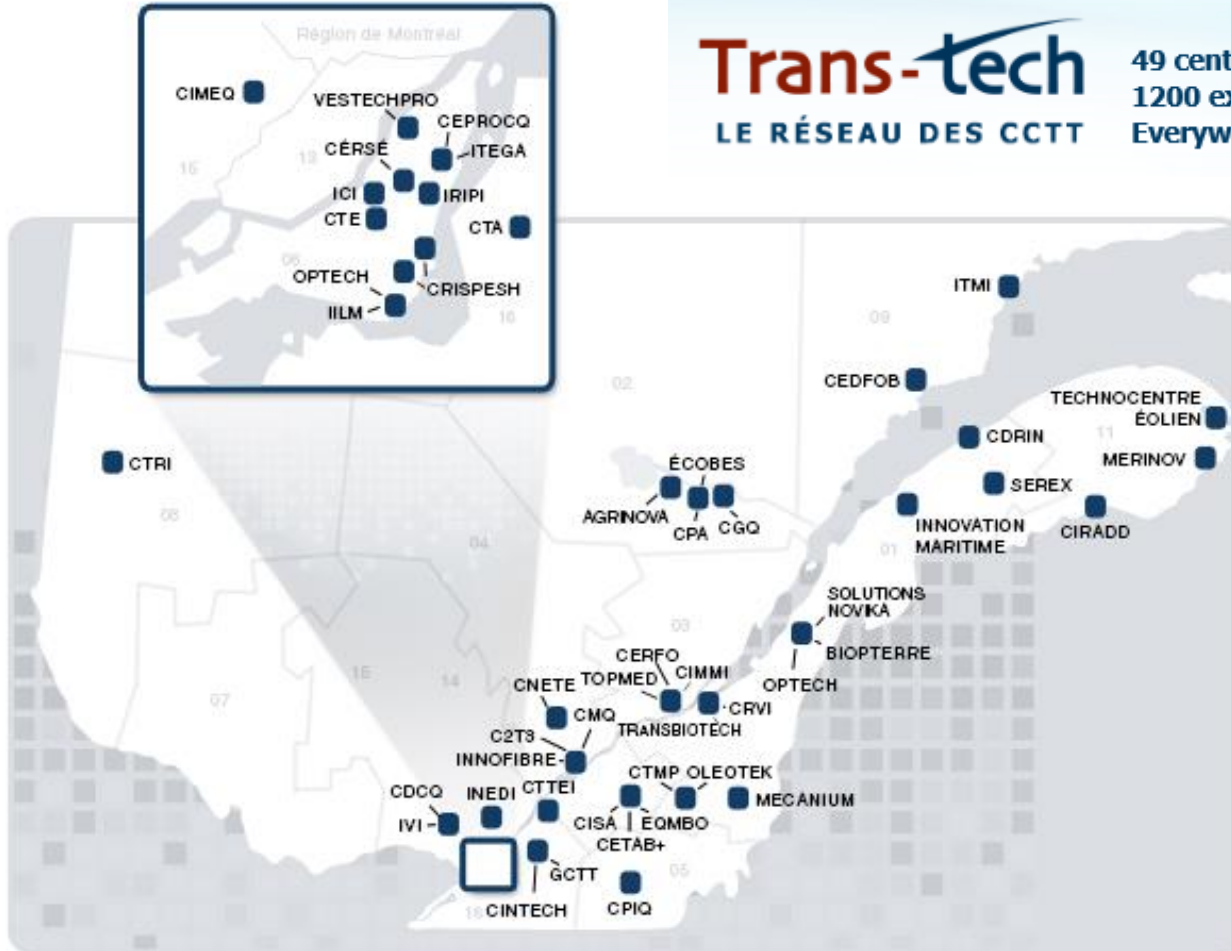
